The Federal Personal Information and Protection and Electronic Document Act (PIPEDA) came into effect in 2004. The personal information collected by **London Newcomers Club** is used only for Club purposes such as distribution of newsletters and directory of members, announcements of events, invites to meetings and/or events, and general club communication. You agree that your name, address, phone number, email, and where you moved from will appear on the membership list distributed to all members. The Club does not sell, disseminate or otherwise provide your personal information to other entities.

3. Personal Use

You agree that you will not use members' personal information or **London Newcomers Club** information provided to you for any purpose other than to achieve the goals of the Club. Members and Club information are not to be used for commercial gain, any form of advertising or marketing, or distribution to third parties. It is the duty of all members to report such irregularities to the Executive immediately and any misuse of the Club or Members' information may lead to expulsion.

4. Club Use of Images
